<p>Next-Day Transcript (Daily) A transcript to be delivered on the calendar day following receipt of the order (regardless of whether that calendar day is a weekend or holiday), prior to the normal opening hour of the clerk's office.</p>	\$6.70	\$1.35	\$1.00
<p>2-Hour Transcript (Hourly) A transcript of proceedings to be delivered within two (2) hours from receipt of the order.</p>	\$8.00	\$1.35	\$1.00
